### GUIDELINES/GENERAL INFO:

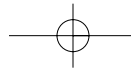
- Check in at the Walk no later than 2:00.
- Please try to get as many sponsors as possible. Use the sponsor sheet on the reverse side and bring it with you to the Walk for Paws.
- You do not need to bring a pet to participate in the Walk.
- Dogs must be current on Rabies vaccine.
- Keep dogs on close leash and do not bring dogs that are in heat.
- We will have clean-up bags available - owners are responsible for picking up after their pets.
- Cats benefit from our programs too, but for safety reasons consider leaving your feline friend at home.

### PARKING:

Please park at the office park on the opposite side of Broken Land Parkway from Lake Elkhorn. There is an underground walkway to get to the Lake so you will NOT have to cross the road with your pet! Follow the parking signs.

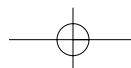

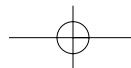

**This Year's Walk for Paws is Dedicated to Duncan Selnick**



Ann was Volunteering at the shelter on the day Duncan arrived. It is a sick feeling to see a dog being given up by the people they trust. "Moving" was the excuse they gave. They were not a destitute family, but like so many others, they did not make accommodations to take him along to their new home. Duncan had been a good friend to their children, and was good with their cats. And this is how he was repaid.

Duncan was terrified. He didn't do well at the shelter. His whole life had been ripped from him and he was a very sensitive guy. He covered in the back of his cage, even let loose an occasional growl, but never with Ann. She had been a witness to his worst hour, and it created a bond that would never be broken. It became apparent Duncan was not adoptable. Although she hadn't planned on another dog, Ann took him home.

Duncan wasn't perfect, but who among us is? He had some separation anxiety, which made sense. He had been dumped in a shelter, and at first, he didn't know Ann wouldn't ever let it happen again. There were some issues, but with patience and love, everything worked itself out. He knew he was safe. He got to cuddle in bed, and had all the attention he could want.

His only complaint was that his Mom didn't take him on enough car rides. Once, when he was dancing around his Aunt Laurie's car in the driveway, she said "Okay, hop in", and they drove around the neighborhood. Duncan was a smart boy, and he never forgot. This became a ritual every single time Laurie came to Duncan's house. He never let her leave without the two of them taking a tour of the block.

Lack of car rides aside, Duncan's family met every need he had, and then some. He gave back what he got, a hundred times over, by being the dog of a lifetime. He truly had a fairy tale life. It was cut short by a rare and vicious form of cancer that did not respond well to treatment.

This once homeless dog had a family that would have given anything to have him longer. Our fondest wish is that all animals will have a home like this, instead of the one they came from. It's what we work toward every single day.

While we always strive for miracles, Ann and Duncan would like you to know that many homeless animals never get one. For this reason, Duncan's family has been a strong supporter of the Walk for Paws since it's inception. They contribute because they know the proceeds from the Walk help save many lives in many ways, each and every day.

If you've had a pet, past or present, there is no better way to honor them than to join us at this year's Walk.
